Minutes of the Meeting of the Board of Directors

- 1. Meeting was called to order at 18:30.
- 2. Minutes from 19 October meeting were approved unanimously.
- 3. Agenda for 9 November 2010 was approved unanimously.
- 4. H. Christensen gave Treasurer's Report.
 - a. H Christensen still searching for free checking but is not optimistic about finding a willing bank. D Jones offered to see if Dan Dalager has access to free checking account.
 - b. ERV value is reported to be \$1,500. H Christensen to confirm.
 - c. D Jones provided ERV's DMV documents to H Christensen.
- 5. Guest Dean Peterson ("DP") gave a presentation on Red Cross Disaster Assistance Team ("DAT")
 - a. DAT responds to fires and other disasters to comfort and aid displaced victims.
 - b. DP described DAT organization structure, call out procedure, training, asserts (including vehicles), and prerequisites.
 - c. DAT needs volunteers and CERT members would be good candidates. P Thatcher to inform ECERT members of this opportunity via the ECERT Newsletter.
 - d. DP to inform DAT Manager, Cruz Ponce, of the ECERT interest in DAT.
 - e. DP to request that Red Cross training be offered in Encinitas at the Community Center.

 - b. C Schmid to seek installation of graphics on ERV with ECERT web address.
 - c. It was suggested that Cub Scouts and Girls Scouts ride on ERV in parade.
 - d. D Jones to seek installation of green lens covers for white flashing ERV lights so we will have red & green flashing lights.
 - e. D Jones to see if ERV PA can be used to play music during parade.
 - f. D Jones to invite Teresa Barth to ride on ERV.

- a. H Christensen checked with several sources for ERV supplies. He will mail a list to possibly donors requesting supplies. D Jones suggested promising to display links to donor websites on the ECERT website.
- b. D Jones submitted a letter to BOD with his ideas regarding ERV.
